

“Base Plan (Japan SIM)” Terms of Service Provision

KDDI Corporation (hereinafter “we/us/our”) will provide Base Plan (Japan SIM) as Single service as follows as prescribed in the povo2.0 Communication Service Contract Terms and Conditions. The official text of this Agreement is in Japanese, and any translations into other languages are for reference purposes only. In the event of any discrepancy between the Japanese version and any translated version of this Agreement, the Japanese version shall take precedence.

1. Overview

The “Base Plan (Japan SIM)” is a povo2.0 rate plan with a base rate starting at 0 yen.

2. Terms of Service Provision

(1) Basic Information on Base Plan (Japan SIM)

- This service does not have a monthly data allowance. When using data communication within Japan, the communication speed is limited to a maximum of 128 kbps for sending and receiving.
- Starting April 13, 2025, at 09:00, if you sign up for the Base Plan (Japan SIM) through channels including Osaka Free Wi-Fi OpenRoaming (available across Osaka Prefecture), OpenRoaming at the Osaka-Kansai Japan Expo site, or the OSAKA INFO (Osaka Official Tourist Information) page, etc., a promo code for unlimited data (24 hours) will be available upon SIM activation. For more details, please refer to our website.
- By purchasing the data toppings specified in the “Data Topping (Japan SIM)” Terms of Service Provision, or the content toppings specified in the “Content Topping (Japan SIM)” Terms of Service Provision, you can use the data capacity and duration specified for each topping at normal communication speed.
- When using Toppings, please select the type of Topping you would like to purchase, through another company's app or on the designated website. However, the toppings available for purchase may differ depending on the application of another company or the designated website.
- The purchase of the prescribed toppings specified in the terms for providing “Data Topping(Japan SIM)” may be required at the time of application. However, if you request cancelation of the initial contract for the purchase of such toppings after applying, you will be subject to cancelation of the initial contract together with the subscription to this Base Plan (Japan SIM).
- In addition, if you register a promo code, etc. (as described in (5)), you may use the data capacity and period specified in the Data Bonus granted by the promo code, etc. at normal communication speeds.
- You can apply for a contract by obtaining consent to the acquisition and use of advertising identifiers and cookie information on the povo2.0 homepage on the

application route.

- You can apply only if you are able to provide a SMS-verifiable phone number from one of our designated countries*, or connect the device you are using to public wireless LAN access services designated by us. When applying for this plan via websites, etc. provided by JCB Co., Ltd. (hereafter referred to as JCB), you must also set a JCB branded credit card issued within Indonesia as a payment method, in addition to providing a SMS-verifiable phone number from one of our designated countries*.
- * For more information on the designated countries, referring to countries or regions associated with the country code of the phone number that you provide for SMS verification during application, please refer to Attachment 1, as they differ depending on the sign-up channel.
- Even if you have an SMS-verifiable line in a country specified by us, you will not be able to apply for a contract if you did not receive an SMS message.
- This plan can one SMS-verifiable line or only be subscribed to one line per device used for application. You cannot apply for a new contract for that device until the current line is terminated.
- After 90 days from the day after the SIM is activated, the SIM will be canceled sequentially.
- Toppings with an expiration date longer than the number of days remaining until cancellation(calculated from the day after the day on which the toppings are to be purchased) cannot be purchased.
- When a notification of succession of the povo2.0 contract holder status is received, the contract will be terminated.
- For the time being, supported languages for this service, including application procedures, service pages, and inquiries are only be available in English and they are as specified on our website, etc.

(2) Data Communication

1) Restriction of data communication usage

If a Topping is not purchased or a promo code is not registered, communication speed will be limited to a maximum of 128 kbps for sending and receiving. In addition, if a large amount of data communication is used within a certain period of time, the communication speed will be limited during congestion (including usage with Toppings and Data Bonuses).

2) Controlling communication to provide service (communication identifying feature)

To provide Data Toppings and content Toppings, communication destinations and the services you are using (contents of communication, such as messages, will not be viewed) will be identified. The identification results will be used to provide flat rates according to the type of the toppings you purchased, to count the volume of data communication, and to control data speed.

(3) Fees for Procedures

- Contract administration fee

Amount excluding tax (amount including tax)	Conditions*2, *3
3,500 yen (3,850 yen)	This applies if you have activated a total of five or more povo2.0 SIM lines under the same name from the day you activated your povo2.0 SIM until the same calendar day last year (anniversary date) (*1).

- *1 Includes all lines covered by the povo2.0 Communication Service Contract Terms and Conditions, including those in the process of application, those already switched to au/UQ mobile, or those already canceled. Lines include lines terminated by us. The total number of lines will be added together between KDDI and Okinawa Cellular.
- *2 This fee will apply for the provisions on the column above if this is the case for a line canceled with us (except the cancelations explained in Article 13-3 of the povo2.0 Communication Service Contract Terms and Conditions.)
- *3 This will be billed in the month or two months after the month you signed the contract.

(4) Functions included in the Base Plan(Japan SIM)

The following functions are included in the Base Plan(Japan SIM) and are available without application. Other terms and conditions for the functions included in this base plan will be determined by the povo2.0 Communication Service Contract Terms and Conditions and our website.

1) Internet connection function

- Data communication is available to and from the Internet. Please note that the use of + messages is not subject to operation check (the phone number subscribed to Base Plan(Japan SIM) cannot be specified as the destination for +Message.)
- This is a best-effort type service, and the quality of communication is not guaranteed.

2) Tethering

- By connecting external devices such as PCs and gaming devices to a smartphone used with povo2.0, data communication can be used with those external devices.
- Data capacity will be consumed for data communications generated by this function.
- The quality of communication is not guaranteed.

(5) Data Bonus

- You have a promo code for the base plan (Japan SIM) that you received through our campaign, etc., you will receive a data bonus for the povo2.0 line by registering the

code on the povo2.0 application, etc. or by fulfilling the conditions of our campaign, etc. data bonus for that povo2.0 line.

- The amount of data earned, expiry date, and other terms will vary by the promotional code obtained. Check the terms of provision for promotional codes, etc.

(6) Order of Data Consumption, etc.

- Data Bonuses, followed by Data Toppings, consume data capacity (if multiple Data Bonuses or Data Toppings are applied, the data capacity is consumed from the one with the earliest expiration date).

In addition Data Bonuses and Toppings that entitle unlimited data usage and Content Toppings that entitle unlimited data usage for eligible content communications shall take precedence over other Data Bonuses and Data Toppings, regardless of their expiration dates.

(7) Universal Service Fee, Telephone Relay Service Fee

- The Universal Service Fee and the Telephone Relay Service Fee will be charged only for the month in which the purchased Topping is valid. However, they will not be charged for the time being. You will be notified on the povo2.0 website when billing of these fees begins.

(8) Other Notes

1) Data communication charges when roaming

- Roaming refers to a KDDI contract making communication within the Okinawa Cellular area or an Okinawa Cellular contract holder making communication within the KDDI area. The carrier in the area where the communication was made will transfer the claims incurred due to roaming to the original subscriber, and the total will be added to the usage fees.
- Fees and other handling related to data communications used during roaming shall be the same as those stipulated in these Terms of Service Provision and other terms of service provision by us.

2) Other

- Calling, SMS, and international roaming functions are not provided.
- Only eSIM is available as the SIM. Reissuance is also not available.
- Contract transfer, number transfer, and MNP are not available.

■ About these Terms of Service Provision

- We may change the terms in these Terms of Service Provision. In such cases, fees and other terms of service provision will be as prescribed in the terms after the update. We will notify you of the new terms and when they will take effect on specified websites and by other similar means, and the new terms shall become valid from the said activation time.

- Any case falling under the Regulation for Enforcement of the Article 22-(2)-3-2-1 of the Telecommunications Business Act (Order of the Ministry of Posts and Telecommunications, 1985, Act No. 25) in which we update the terms of service provision by filing an application, we will release the details on our webpage in advance instead of notifying and providing an explanation to individual customers.
- Terms of service provision (including the povo2.0 Communication Service Contract Terms and Conditions, our other various terms of service, the povo Global Privacy Policy rules, etc.) will apply to matters not prescribed in this Terms of Service Provision. Details such as terms of service are available on our webpage.
- Other terms of service provisions for povo2.0 will be as prescribed on channels such as our webpage.
